NOW, THEREFORE, upon the signing of this Agreement, the Eugene Fire & EMS Department will make available to the above named Observer an opportunity to observe department personnel while they perform their duties; however, the department reserves the right to terminate observation privileges at any time.

The above named Observer, by signing this Agreement, releases the Eugene Fire & EMS Department, from any liability whatsoever arising out of this observation and all activities and events incident thereto.

Eugene Fire & EMS Department Observer & Event Rules

While observing and participating in Teen Career Day, an Observer is expected to abide by the following rules:

1. Observer must attend the morning career fair in order to attend the afternoon hands on drills. Lunch will be provided for all participants.
2. Observer must wear a Eugene Fire & EMS Observer tag that will be issued at the beginning of the day's activities. The Observer must display the tag on his/her outermost garment at all times. The tag will be returned to the Company Officer at the end of the day's activities.
3. Observer should wear no patches, logos or graphic t-shirts. Dress should be dark blue or black pants and light colored shirt. Clothing should be free of holes and in good repair. Open-toed shoes are not allowed. **You will be asked to leave if you do not comply with the aforementioned dress code.**
4. **All** observers must complete this form as well as the Agreement and Release form. Both forms must be signed by a parent or guardian and brought with the Observer the day of the event.
5. Observer is not allowed to take pictures or make tape recordings unless the Deputy Chief grants permission in writing.
6. All observers must stay with their group at all times. If you must leave your group for any reason,
7. please inform your Guide or Company Officer prior to leaving the group.
8. Report any injuries to the Guide or Company Officer, immediately.
9. Your demeanor and behavior must **BE PROFESSIONAL** at all times. There are things on this campus that can cause injury so it is imperative that Observers follow all rules and regulations. Eugene Fire & EMS Department reserves the right to ask anyone to leave the campus for any reason.
